This guide walks you through the steps required to complete and submit the official application for the Food Bank of Alaska MTY program. Follow these instructions to ensure all personal and household information is accurately provided for a successful submission.

Meals to You is a Summer Food Service Program (SFSP) which will provide a **5-day breakfast and lunch** meal box directly shipped to students in eligible school districts who choose to participate.

34 rural school districts are enrolled to participate. The school districts have agreed to verify the student's enrollment status in the district and the National School Lunch Program (NSLP).

The 5-day meal box will provide a variety of shelf-stable, breakfast and lunch meals, **free of cost to participating students**. All meals will meet the nutritional requirements established by the United States Department of Agriculture (USDA).

The Meals to You Student Application will be open from **April 1-April 30, 2026**. The first box will be scheduled to arrive in the first week of June 2026 and will continue until the start of the fall school year.

b) Income Requirement

- Students must either be approved for Free or Reduced-Price Lunch through the National School Lunch Program, or
- Enrolled in a CEP (Community Eligibility Provision) school or
- Households may complete an income eligibility form to determine qualification.

c) Rural Designation

- Participants must live in a USDA-designated rural area of Alaska during the summer months

Household Eligibility Consolidation

If one child qualifies for the Meals to You (MTY) program, **all children in the household** are eligible to participate. This includes children who are not enrolled in school under the age of 18.






